- 1) Individual family compensation funds may provide higher allowances.
- 2) Individual family compensation offices may provide additional and higher allowances.
- 3) The first amount applies for children up to the age of 12, the second for children aged above 12.
- 4) The first amount applies before the 18th birthday, the second after the 18th birthday.
- 5) The first amount applies for the first two children; the second for each subsequent child.
- 6) 3,000 francs per child in the case of multiple births or adoptions.
- 7) Child allowance for incapacitated children aged 16 to 20.
- 8) Child allowance for children in education under the age of 16.
- 9) As of January 1, 2022: Reduction of child allowance as of the third child. However, the total amount (according to the entitlement until 31.12.21) will not be shortened as long as the number and kind of children allowances remain unchanged.
